#### **Committee Reports:**

**NVFC** Spring Meeting no meeting due to Covert

- (1) George Report: NVFC:
  - (a) Junior Firefighter Program, Bob Timko from Hudson County, NJ has been selected through a nationwide nomination process as the recipient of the 2020 NVFC Junior Firefighter of the Year Award. October 16, 2020 at the Embassy Suites Hotel in Wilmington, North Carolina with a celebration lunch
  - (b) Japan donated \$10,000 to American wildfires
  - (c) NVFC expressing opposition to section 10402 of the Health and Economic Recovery Omnibus Emergency Solution (HEROES) Act, which waives statutory protections ensuring that volunteer and smaller fire departments receive an equitable share of funding under the Assistance to Firefighter Grant (AFG) program for the \$355 million appropriated for AFG in FY 2020. Volunteer fire departments are struggling with the impact of COCID-19 just as their big-city counterparts. Social distancing has disrupted fundraising efforts for thousands of smaller fire departments, even as the economic downturn is reducing local tax support. NVFC urge the House & Senator to remove the above-mentioned waivers of statutory protections in the HEROES Act before the bill is voted on by the House of Representatives.
  - (d) Volunteer Retention Research Report: Two thirds of respondents feel their department have (or had) a problem with volunteer retention, which includes nearly 70% of current department leadership. Reason for Leaving (1) groups that exclude others; (2) Leadership that descent's focus on or support the needs of members. (3) Different generations do not get along; (4) Lack of camaraderie or sense of community among everyone in the department.
  - (e) Individual membership of \$18.00 eighteen dollars a year gives 410,000 ACCIDENTAL & DISMANTABLE COVERAGE plus schooling and discounts plus much more.
  - (f) A message from NVFC Chairman Steve Hirsch March 19, 2020, dealing with 911; "So, first of all, let me assert my firm belief that the only thing we have to fear is...fear itself...nameless, unreasoning, unjustified terror which paralyzes needed efforts to convert retreat into advance In every dark hour of our national life a leadership of frankness and of vigor has met with that understanding and support of the people themselves which is essential to victory. And I am convinced that you will again give that support to leadership in these critical days."
- (2) Charlies Siedenburg NJ Fire Safety Commission Report: S 1634 Raises the Maxime age from 45 to 60 for eligibility for exempt firemen's certificate. NJS40A:14-56 & RS 43:17-9 this must be voted on and if passed signed by the governor to become law.
