- **1. NVFC** Fall 2021 Meeting Oct. 13 -15, 2021 at Jackson, Wyoming: George mentioned it was very expense in Jackson. Hometown Heroes Assistance Program was passed by the MN Legislation which provides \$4 million to cover Every firefighter in MN with an up \$20,000 critical illness policy covering cancer, cardiac issues, stroke, and mental health care. It also finds free training to firefighters for prevention of these issues.
- 2. George sent letter to Honorable Craig Coughlin, Speaker of the Assembly requesting no fee for fire fighters auto plates.
- 3. Survey to provide valuable information that volunteer experience and environment can be improved.
- 4. **VFA Grant Program** 50/50 cost share basis to pay for training, equipment, and protective clothing to help prepare for Wildland fires.
- 5. Support Volunteer First Responder Housing Act (H.R. 4377/S 2316)
- 6. Firemen's Home Family must pay executive charges for netting & etc. for firefighter in new wing.
- 7. Joint Anti-Harassment, Bullying, and Discrimination
- 8. NVFC Spring meeting April 7 to April 9th, 2022, in Alexandra VA.

## **Charlies Siedenburg NJ Fire Safety Commission Report**

- (1) Apparatus Driver/Operator not to allow for a "driver only" certification instead require that Chapter 5 of NFPA 1002 "Apparatus Equipped with Fire Pump" be added.
- (2) Junior Firefighter proposed regulation still must be submitted to the Governor's office for approval.
- (3) OEM Directive will mandate ICS-200 training for First Responders and Providers; on-line IS-200 can be taken to meet this requirement.
- (4) A5075 make Fire Museum & Fallen Fire Memorial independent organization, passed both houses.
- (5) Firefighter 1 and 2 no change (270 hours) US Supreme Court and ADA state that you cannot read HazMat exams to any student; the student must be able to read and comprehend the ERG without any assistance.
