Committee Reports:

NVFC Fall Meeting Sept. 27 thru Sept 30th, 2017 at Kearney, Nebraska: **No report** As Director Joseph Jubert resigned as Director from NJ for the NVFC.

- 1. NJ Fire & Emergency Medical Service Institute- Charles Siedenburg mentioned he hasn't heard and we should ask for our \$200.00 dues money paid for annual dues should be refunded.
- 2. Firemen's Home report that this is a long term care unit instead of what was originally set up back many years ago. It was reported that 67 guest out of 96 beds available.
- 3. New Jersey Firemen's Association (a) January 1, 2017 a special relief change every association can give \$5,000.00. Give max first than file yellow copy for additional amount for **need up to the \$5,000.00**. This special need is paid out of the state office. An association can submit applications for Special & Supplemental Relief at the same time if the **need** is there. (b) Any member with a line number can request application for relief. Required **Need** and prove supporting documentation including the latest federal 1040. Former members with a qualifying number and widows/widowers (non-remarried) are eligible for relief if there is a **need.** (c) Feb 1st Officers listing report due; Feb. 20th Financial Reports are due; Feb. 28th Membership Reports; May 1st Convention Delegates and Alternates form are due; June 14th copy of 990 filing. (d) Delegates & Life Members Convention Expenses reimbursements have been increased. Base on the local treasury, the representative can vote to pay less than the maximum allowed for your County. (e) New State Office in Wall Twp.; Legacy Construction Management, Inc. from Brick, NJ has been selected. Final approval from Wall Twp. has been approved. After all bids were reviewed by the architect and attorney Woodward Construction from Matawan was accepted. (f) May 1st, 2017 the New Jersey Firemen's Home received a check from the Firemen's Association of \$8,348,900.00. (g) There have been three incidents of families receiving notification that a decreased New Jersey firefighter has been classified by the POSB as being a line of Duty Death. The claims have been reclassified by the NJSFA as LODD and additional payments to the families have been made. Make sure you document fire ground & fire station illness & injuries no matter how minor they may seem. (h) Changes are being made to the State web site that should provide more information and make it more users friendly. The Compendium and 2016 Convention minutes (Red Book) are now online.
- 4. Legislative Committee. (1) Aug. 07, 2017 the New Jersey Supreme Court ruled that municipal fire districts are subject to the requirements of the state's Open Public Record Act (OPRA); volunteer fire departments are public agencies and have to follow OPRA. (http://www.njopralaw.com/?p=1407). (2) OPRA privacy emption of the NJ State Firemen's Assn Obligation to provide relief applications. Supreme Court ruled Aug. 5, 2017 on the side of privacy and denied request for disclosure. (http://www.njopralaw.com/?p=1396). (3) Aug. 03, 2017 Supreme Court held that records showing financial relief awards made to needy firefighters are confidential under OPRA'S privacy provision (http://njopralaw.com/?p=1391).
